- Storage guest will be courteous and gracious to all guests & employees on premises at all times
- Upon request from Storage guest & with a min of 24 hr notice, LKR & its employees will **ASSIST** with retrieving/racking and launching kayak/canoe/SUP from our standard location
- Upon request from Storage guest & with a min of 24 hr notice, LKR & its employees will **ASSIST** with loading/unloading, strapping and transporting guest's kayak/canoe/SUP on standard scheduled trips. Trips may be cancelled if minimum number of rental guests is not met
- Storage Guest will provide their own lock
- Storage Guest agrees that if kayak/canoe/SUP/equipment is not removed prior to end of season date, LKR has full rights to cut lock and remove kayak with additional fees associated including additional charges applied to card on file, up to and including kayak/canoe/SUP becoming property of LKR
